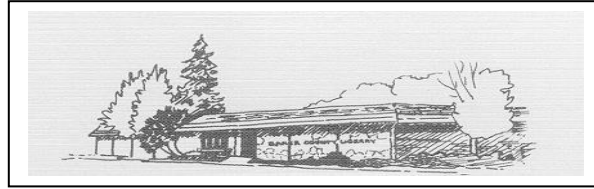

**BID INFORMATION SHEET FOR POTENTIAL INTERNET VENDOR
USAC E-RATE PROGRAM, FUNDING YEAR JULY 1, 2025 – JUNE 30, 2026**

1. GOODS AND SERVICES REQUIRED:

Vendor must acknowledge they are able to deliver goods and services to one or more of the following locations and provide the required services as stated:

| Huntington Branch Library 55 E Jefferson, Huntington, Oregon | Has 10 down/10 up over wireless cellular technology Desire 25Mb down/10 up, Fiber or other service to achieve desired service |

Baker County Public Library, Baker City, Oregon (Main Branch and Administrative Offices) and Bookmobile;
Branch Libraries: Haines Branch is in close proximity to Baker City, plus 4 locations in rural/frontier communities with addresses given above.

2. Vendor Required Information and disqualifications:

The vendor MUST state the location of their headquarters and the SCOPE of their service area. Service area is critical to these remote locations. This information is preferable in writing but may give the address of a website that clearly defines this information. For Branch Locations, state how the services will be delivered and the dependability rating or expectation of services to this location. Bids lacking this information will be disqualified from consideration.

Disqualifications: The vendor MUST already be registered with the USAC E-Rate program. Vendors not registered will be disqualified. SPAM and/or robotic responses will not be considered valid bid responses and will be disqualified from consideration.

3. Vendor Additional Costs and Factors:

The vendor MUST clearly state any other factors including costs to be charged in addition to the monthly service fee and anticipated down time percentage or similar rating. For example, state anticipated costs for installation costs, setup costs, equipment charges, costs to transfer services.

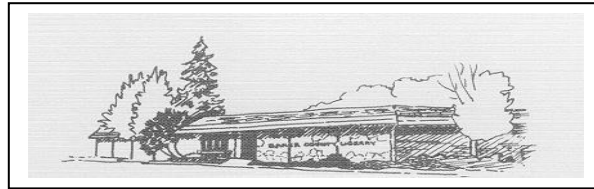

**BID EVALUATION CRITERIA FOR INTERNET SERVICES
USAC E-RATE PROGRAM
FUNDING YEAR JULY 1, 2023 – JUNE 30, 2024**

| Other factors (potential service interruption factor, installation costs, any other factors IT deems pertinent) | 10 |

*** Eligibility Requirements to submit a bid and Disqualification factors:**

Bids that do not meet the requirements will be disqualified and are not eligible to be evaluated further.

1. Vendors must already be registered with the USAC E-Rate program as a Service Provider to be eligible to submit a bid for District services at any location; those who are not will be disqualified. We will verify that vendor has a current SPAC number on file with the USAC.
2. Vendor must be able to provide services to rural/frontier location(s) listed, or that they indicate they are bidding on, in order to qualify to submit a bid; the vendor will be disqualified if the branch is not in their service area.
3. SPAM and/or robotic responses will not be considered valid bid responses and will be disqualified from consideration.

Vendor must be able to provide services to rural/frontier location(s) to qualify as eligible:

The District libraries are all located in Northeastern Oregon: Baker City (administrative offices and main branch), Haines, Halfway, Richland, Huntington, and Sumpter communities.

- (2) Based upon proven professionalism, reliability, and quality of service as evidenced by consumer and government data. We will also consider any prior experience with the vendor, down time history, and how long a vendor has been in business. We will check the Better Business Bureau and other available consumer data.
- (3) Vendor presence in the Eastern Oregon region will be given preference points.
- (4) IT preference points; IT wishes to avoid reconfiguration of complicated system unless bidding vendor can provide a solid bid that demonstrates that the District will receive the same service level of technology or better. The current vendor is already providing a high level of technology and may be given preference, as IT deems pertinent.

Criteria determined by E-Rate Program Evaluation Committee (Business Manager, Technology Manager and Library Director) in order to best serve the needs of the Library District.
